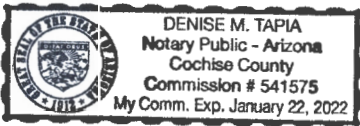

## ELECTION NOTICE

To all property owners and qualified electors of The Villages at Vigneto Revitalization District #2 (the "District"):

Pursuant to the provisions of Sections 48-6817 and 48-6818 of the Arizona Revised Statutes, notice is hereby given that on December 12, 2018, an election (the "Election") will be held at the place set out below for the purpose of electing three property owners to serve on the board of directors of the District (the "Board"). Real property owners in the District as shown on the property tax assessment roll who are qualified to vote pursuant to Section 48-6818 of the Arizona Revised Statutes are eligible to vote in the Election. The property owners elected to the Board will hold office for a term of four (4) years or until their successors are qualified and elected.

Voting at the Election shall be by paper ballots and other ballot forms. The Election will be held on December 12, 2018.

The polling place will be Benson City Hall, 120 W. 6th Street, Benson, Arizona, 85602.

The polls will be open from 9:00 a.m. to 4:00 p.m. MST.

A general plan for the District is on file with the District Clerk (currently, the City Clerk).

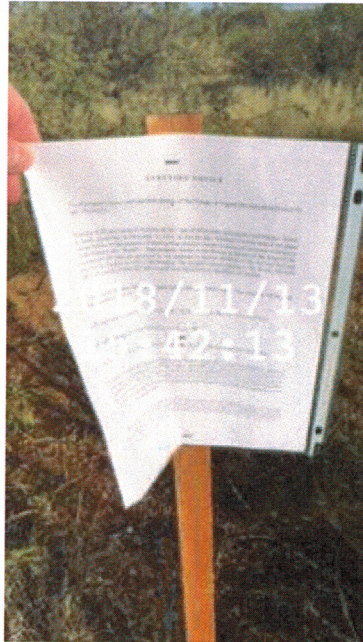
The election register denoting the names of the holders of the lands within the District, the number of acres held by each and the number of votes which they are entitled to cast will constitute the register for the Election and will be on file with the District Clerk (currently, the City Clerk) no later than December 12, 2018. The District Clerk (currently, the City Clerk) will make available at the above-described polling place, a registration list or copy thereof listing all registered electors entitled to use such polling place.

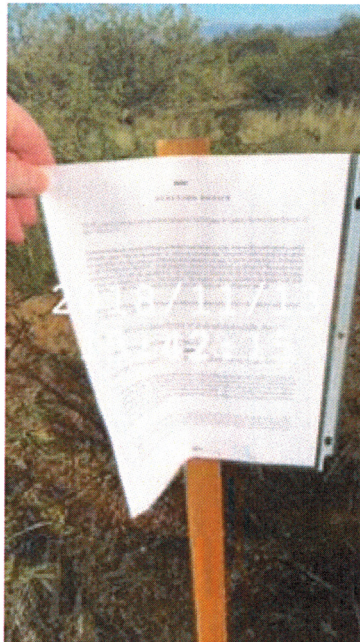

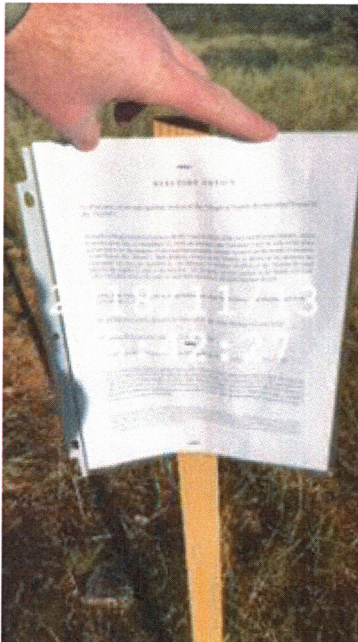

MAP AND PHOTOGRAPHS OF PUBLIC PLACES AT WHICH NOTICE WAS POSTED



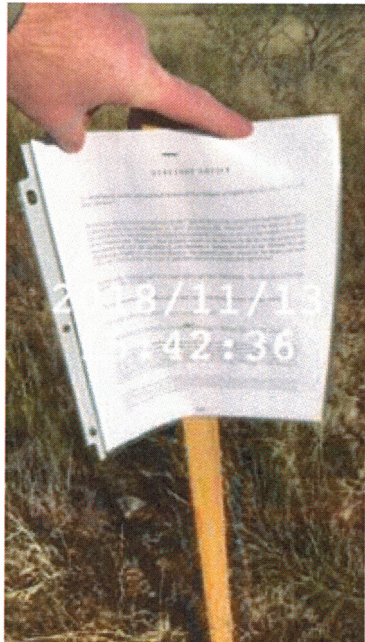


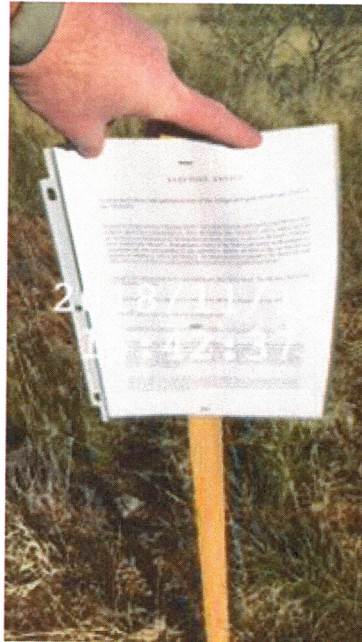




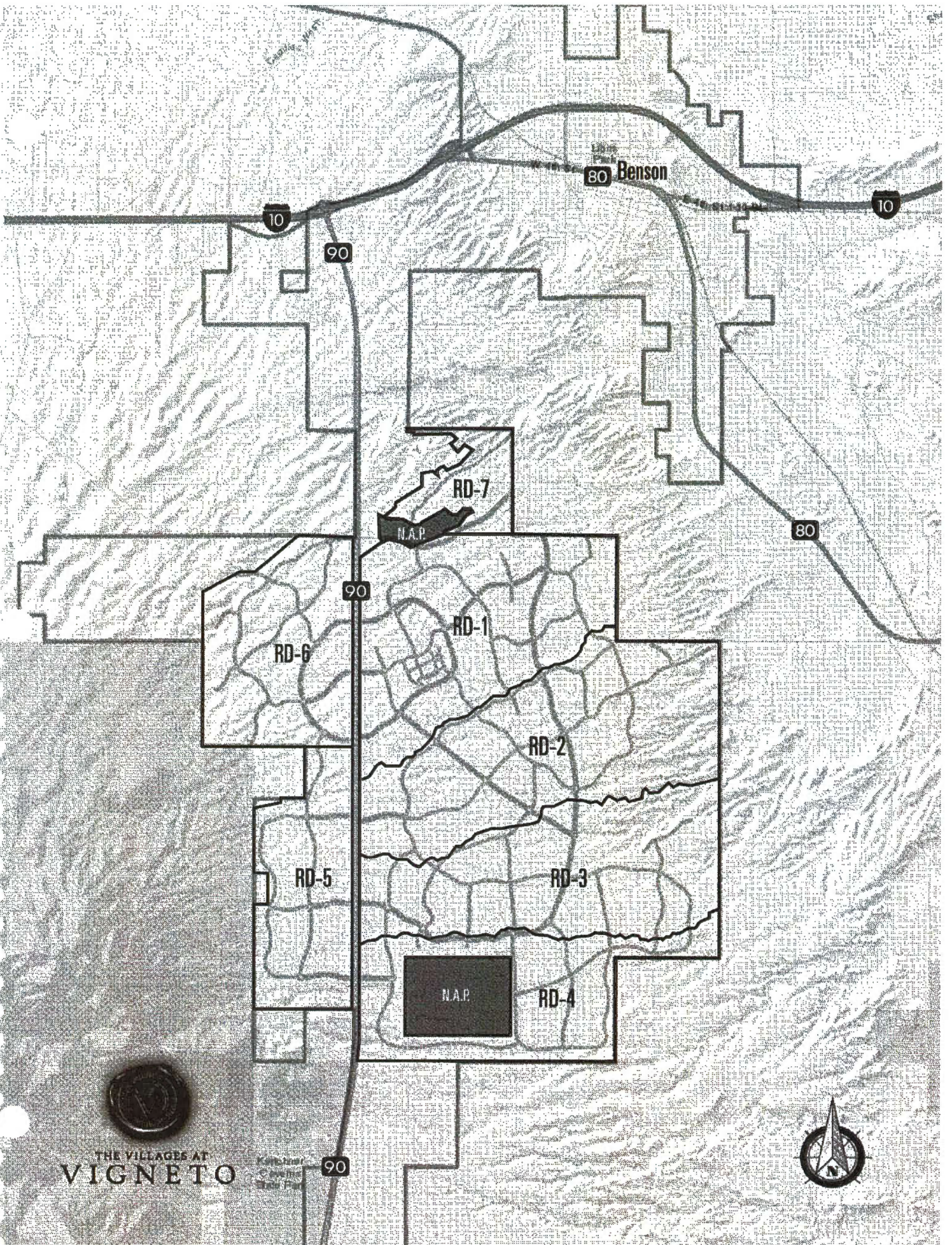
